## Walter Norman Reiman

He was/is known to his friends [and others of whom there are probably many] as **“Wally”**. He retired from Queensland Rail [QR] in April, 1992.

Another public document, called Telstra's White Pages discloses that **Walter Norman & Gwendoline Jean Reiman, 22 Deniven St, Corinda, Q. 4075, has the telephone number of +61 7 3379 8097.**

Doing a Google search [Google is just so good], shows W Reiman and G Reiman mentioned in MINUTES OF THE ADJOURNED SPECIAL COUNCIL MEETING OF THE CUNNINGHAM DISTRICT BOWLS ASSN HELD AT CORINDA BOWLS CLUB ON 17 January 2006; at the URL of <http://www.cdba.org.au/files/JAN06MIN.pdf>.

Reiman is also mentioned on the website “under construction” of <http://www.cdba.org.au/committee.html> for the **CUNNINGHAM DISTRICT BOWLS ASSOCIATION INC.** A few of these websites have the above 'phone number disclosed for Reiman. It appears that this bowls club has updated its website from [www.cunninghamdba.org.au/aboutus.html](http://www.cunninghamdba.org.au/aboutus.html) which is no longer online but still google lists it with Reiman's name and his phone number.

This suggests there are many people who know of Wally Reiman by name. All the people mentioned on those sites would presumably know Wally Reiman. Now, Wally Reiman is a lowlife, bottom dwelling, perjuring bully of a disabled guy and Reiman is a criminal. We suspect that he thinks he has got away with it. It was in 1974, 33 years ago. Once a lowlife always a scumbag. He defrauded our prime informant and Official AustLawPublish photographer Haig [note our *HAIGPHOTO* labels]. Haig was and is disabled. His being disabled assisted Reiman to be the

gutter dwelling perjurer, so to defraud the disabled Haig.
